### Membership Categories:

**Take a 10% Discount if you were a 2019/20 Member affected by Covid-19 Closure or if you are a New Member (not a member within past 5 years)**

Individual Membership \$850.

Adult Full Season Membership

Couples Membership (NEW) \$1150.

Full Season Membership for Married Couples, Partners, Single Parent & Child – Must be living in same household. If membership includes an existing member (someone who has been a member within past 5 years), it will not benefit from the new member 10% discount.

Family Membership \$1450.

Full Season Membership – All family members must be living in same household. If membership includes an existing member (someone who has been a member within past 5 years), it will not benefit from the new member 10% discount.

Junior/Student (NEW) \$350.

Full Season Junior/Student Membership – Up To Age 22 and Must have a Student ID. This membership is not eligible for the new member 20% discount, nor will it have the *season long* weekly booking privilege, however, may book courts, as available, up to 1.5 hours/day and play with other members as often as desired.

**\*\*Shareholder Option:** Interested in becoming a **Shareholder** (Limited Availability): Shares are currently being offered by 4015, Inc. for \$10,000.00. Shareholders will not pay a membership fee and have additional privileges and responsibilities, as approved by the board. ### **Membership Rules of the Road:**

1. *Members* may reserve Court time as needed, up to four (4) days in advance, for up to 1.5 hours per day. (*Shareholders* may reserve time up to 7 days in advance, for up to 2 hours per day.) Court reservations must be cancelled at least 24 hours in advance (*sooner* is preferred), if their court will not be used.
2. Members and Shareholders may also request one (1) season-long recurring weekly court per Membership-type or Share, up to two hours, for a doubles group of 5 to 7 players. It is strongly preferred that this time be used for doubles groups only, however, if singles is requested (and approved), only 1.5 hours will be allotted. These Groups will be booked under one member name and that member will be responsible to ensure the court is used or cancelled at least 24 hours in advance. If that member is away, please assign another responsible individual within the group to ensure use or cancellation (and, if necessary, please contact an Administrator to cancel or assist – [Play4015Tennis@gmail.com](mailto:Play4015Tennis@gmail.com)). *\*Please only request a season long court time if you are certain it will be used weekly.*
3. Members/Shareholders may play in as many groups as they desire, but only one recurring court may be booked under their name (per Membership/Share).
4. **Mandated Cancellations:** Every member/shareholder is asked to cancel their court as soon as they know they will not be using it (the sooner the better). There will also be a **No Show** reporting element to the online Court Reservation System, so if a member notices a booked court is unused, he/she may click on “*No Show Report*” on that reservation & it will anonymously send a report it to the Administrator. A polite email will then be sent to that member. The hope is to encourage court cancellation when booked courts are not in use, not to be a policing force.
5. Members/Shareholders will be asked to Sign-In for their recurring court by initialing the court reservation sheet for their time slot when they arrive. These sheets will be collected regularly, along with the Guest Sign-In sheets.
6. After the season is officially over (mid-June), members are still welcome to use the court until the following season begins (mid-Sept).

**Guests:** \$20 guest fee per Session/Play - Limited to ten (10) sessions per season.

The Guest will sign the guest sheet at the club and the member host must ensure that their guest fee is placed in an envelope (provided), with their name, and places it in the Lock Box at the Club. If a guest wants to play more often, we URGE them to join! It's a great way to create a vital, sustainable community at 4015 Tennis.

After you've joined & sent in your Fee, please request the password for the Member's Only page of our website. When there, please register for our online Court Reservation System (& set up your personal user name/password for that system) & note the front door combination.
